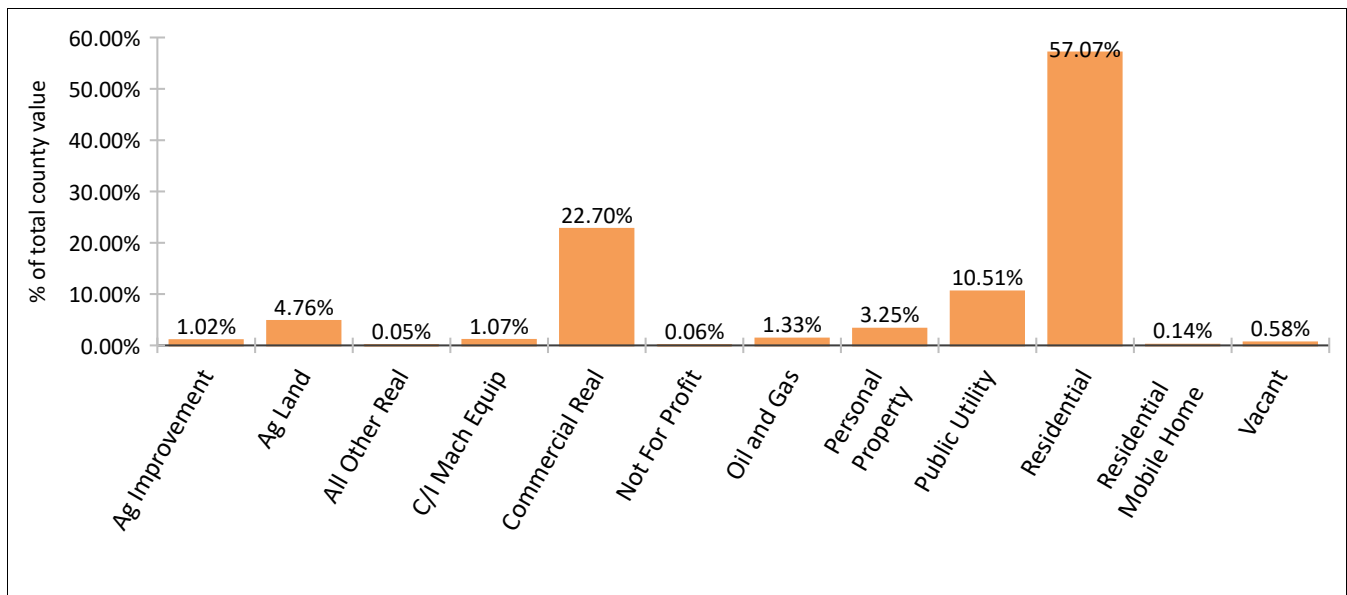


Chart Displaying Percent of Property Tax by District
